Our Summer Associate Program

Work Assignments

Felhaber attorneys assign work directly to summer associates. In addition to research and writing, you will have opportunities to attend trials, depositions, closings and client meetings.

Feedback and Evaluation

Summer associates receive informal feedback and formal written evaluations. They are encouraged to seek feedback from the attorneys for whom they work. In addition, summer associates receive two formal performance evaluations during the summer. Each attorney who has assigned the summer associate work is invited to submit an evaluation that is reviewed with the summer associate by members of the Felhaber Recruitment Committee.

Mentoring

Every Felhaber summer associate is assigned a mentor who is a member of the Recruitment Committee. The mentor serves as a valuable resource on the inner workings of the firm, substantive law and other issues that arise during the summer.
